1. Apologies for absence

There were no apologies for absence.

2. Election of Chair

Cllr Beckett was re-elected Chair, proposed by Cllr March and seconded by Cllr Mosley.

3. Election of Vice-Chair

Cllr Bowman was re-elected Vice-Chair, proposed by Cllr Beckett and seconded by Cllr Nutting. Cllr Nutting to shadow Cllr Bowman during the next 12 months. *Action: Cllr Nutting*

4. Election of representatives to outside bodies:

a) Almshouses
