23/6.1 Apologies for Absence

Apologies were received from Cllr R Boyack and Cllr I Wakefield.

23/6.2 Co-option of new councillors

It was **RESOLVED** to co-opt Mr Philip Curzon to the Council. Mr Curzon signed the acceptance of office and joined the councillors.

23/6.3 Variation to the order of business

23/6.4 Declaration of Members Interests

There were no interests declared.

23/6.5 Public Speaking

Cllr D Murphy (DCC)

Cllr Murphy gave an update on the Via Gellia Road project. He has spoken to the lead project manager and now that feedback has been received from consultations designs are being done which are being re-costed. Some plans have been sent to residents at the Clatterway for review around the areas of road crossing. The major issue with the project is the budget, the County Council were granted the money before covid and had no one to design the work at that time but have now got people in however, costs have gone up in three years with inflation. This means some lesser features may disappear due to the increased cost. It was also found that DCC don't own all of the verges along the Via Gellia and some trees on the stretch require removal for ash die back but some of this work will have to be done by the land owners. The Peak Park are liaising with highways over the gantries as the Peak Park aren't happy with them however the cameras are required by the government as the major element of the project to slow the traffic is the cameras so this need to be in. By October the council should have drawings of the project.

Cllr Murphy reported that outside Masson Mills the retaining wall had failed due to the trees damaging the wall. The council had cut back the trees previously. The wall is going to be repaired on the $10^{\rm th}$ July with the County council paying for the work.

Cllr Murphy is also looking into the footpath sign reported by Jeremy Beckett.

John Mee (Footpath Warden)

Mr Mee reported the dangerous overhanging trees on the A6 at Cromford courtside that are obscuring the lights and road signage. Cllr Murphy will report this.

There are overhanging hedges at 22 and 24 the Hill causing problems and pushing people on the pavement into the road. There are also overgrown hedges at 27 and 17 Hawthorn Drive also pushing people into road. Cllr Murphy will report this. Cllr Birch will send photos.

The Dene Hollow footpath was raised at the Quarry liaison meeting and it was noted that it was to specification. Mr Mee will walk it and report back.

The Lime yard was raised by a resident and it was reported that a private owned garage been chained off with a tree down. It's not clear whether tree has been cut or fallen. There is also no lighting there now which is making it unsafe. The council will try to establish who is the landowner, if tree was cut or fallen and if the chain is permitted.

- a. Cromford Institute the AGM will be held next Wednesday at 7.30pm. It's been advertised on Facebook. £120 was raised from canine first aid course. During the Celebrating Cromford weekend the institute held an exhibition and raised just under £300 over the weekend. The institute is now in profit with the 200 club and Cllr Fraser has donated £100 from his win. The painting has been done and the rubbish removal done. The accounts will be sent to the Clerk.

- c. Cromford Meadows Sports Club There is no further update.
- d. Celebrating Cromford Report from Cllr Fraser was noted (Appendix A). Cllr Birch reported that the food truck and the Bell will donate £50 to Celebrating Cromford.

It was noted that the bunting needs removing. Mrs Taylor-Wilde will help if she is available. Cllrs Birch and Fraser will organise the removal for Saturday at 1pm.

There will be a meeting organised for Tuesday at the Boat from 6pm. Fundraising is being looked at.
